Company Breaks Ground for New Manufacturing Facility

YANG LING, China--(BUSINESS WIRE)--April 21, 2004--Bodisen Biotech, Inc. (stock symbol: BBOI), a Delaware corporation, is a leading organic fertilizer manufacturer in China (www.bodisen.com). The company announced today that it has received \$3.6 million (30 million Yuan in Chinese currency) in contracts from 9 customers for 2004 product delivery.

In addition, to address increasing demand for the company's products, Bodisen has initiated its expansion plans and has broken ground for a new manufacturing facility in Yang Ling. The company currently produces approximately 100,000 metric tons of organic fertilizer annually. The first phase of the new manufacturing facility will effectively add 100,000 metric tons in annual production capability. The new facility is expected to be operational in the fourth quarter of 2004 and will include a research facility that will enable the company to further expand its R&D efforts.

"The agricultural sector in China is a high growth segment of the Chinese economy. Demand for our products is very strong. Our fertilizer products are organic therefore do not harden the soil as chemical based fertilizers do. This is very important for Chinese farmers whose livelihood depends on growing crops out of their allocated fields." commented Ms. Qiong Wang, Chairman and CEO of Bodisen. "In addition to our continued efforts on marketing of high margin fertilizer products, we have expanded our product distribution network to a total of 580 locations in China - a net increase of 27 distribution centers in the first quarter," she continued. "To date, we have about a 10% market share in Shaanxi Province, an agricultural hub in China. There are tremendous growth opportunities for us. We anticipate that we will continue to expand our market share in Shaanxi and throughout China."
